VISAS FOR ATHLETES

O Visas

For persons with extraordinary ability and achievement in the sciences, arts, education, business, athletics, or extraordinary recognized achievements in the motion picture and television fields, demonstrated by sustained national or international acclaim, to work in their field.

P-1 Visas

To perform at a specific athletic competition as an athlete or as a member of an entertainment group. Requires an internationally recognized level of sustained performance. Includes persons providing essential services in support of the visa beneficiary.

P-1S Visas

To serve as essential support staff to a P-1 holder. There is a similar visa available for support staff of the O-1 visa holder. This visa is appropriate for anyone that serves as agent, manager, or coach of the P-1 holder. This can be a parent of the P-1 holder if they service one of these roles.

P-1 & O-1 Visa Benefits

P visas can last for several years and survive changes in teams and leagues. The athlete can safely travel in and out of the country and there is options available for immediate family members.



Visas for Executives - L-1 Intra-Company Visas

The L-1 category enables a U.S. employer to transfer an executive, manager or a professional employee with specialized knowledge relating to the organization's interests from one of its affiliated foreign offices to one of its offices in the United States. This classification also enables a foreign company which does not yet have an affiliated U.S. office to send an executive or manager to the United States with the purpose of establishing one.



L1 - Visa

Who Qualifies for an L-1 Visa

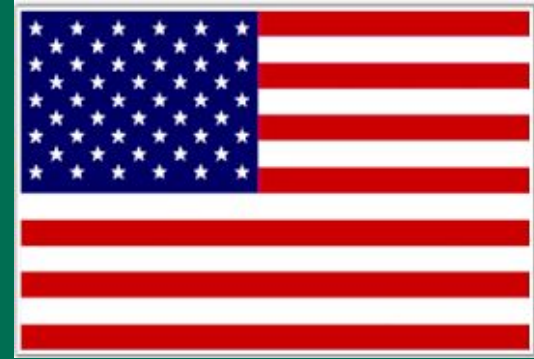
L-1A Managers/Execs

- ▶ Executive or Manager in the Company for a least 1 year
- ▶ Has educational background to support their position.
- ▶ Will be maintaining executive/managerial position in the U.S. company

L-1B Special Skills

- ▶ Must have special and/or advanced knowledge in business function
- ▶ The business function must be integral to business model
- ▶ Proof of previous success using special/advanced skills
